### **Challenge: Barriers to innovation**

- Insufficient enabling framework conditions, e.g. access to finance and risk capital, legal barriers, evidence, best practices, incentives, etc.;
- Lack of strategic innovation leadership and employee engagement in innovation at all levels of government;
- Limited knowledge of methods and lack of skills and ability to drive effective innovation processes in practice;
- Insufficient generation and use of data to inform, drive, learn from and measure public sector innovation;



# New innovation paradigm and design principles

1	Co-design and co-creation of innovative solutions (with other Member States, other parts of government, businesses, the third sector and citizens)
2	Adopting new and collaborative service delivery models (across public, private and non-governmental actors, both within and across national borders)
3	Embracing creative disruption from technology (the pervasive use of social media, mobility, big data, cloud computing packaged in new digital government offerings)
4	Adopting an attitude of experimentation and entrepreneurship (government itself needs to become bolder and more entrepreneurial)



# **Recommendations – Logic**

- EU-level governance model for ensuring a systematic, strategic effort at EU level: 3 proposals
- Set of concrete actions that will dramatically power innovation efforts EU-wide: 9 recommendations



# An EU innovation governance model

- Public sector innovation platform chaired by the President of the EU Commission?
- 3-year innovation mainstreaming programme of all major EU initiatives
